



WATER-BASED SURFACTANT

GENERAL INFORMATION

Stick-It-Tight greatly improves the activity and effectiveness of foliar-applied agricultural chemicals including insecticides, herbicides, fungicides, and defoliants. Stick-It-Tight is a nonionic penetrating surfactant designed to reduce the surface tension of spray, allowing droplets to spread out and stick over a larger surface area of the leaf. Stick-It-Tight provides more uniform spray coverage and improves chemical absorption and efficacy while drastically reducing evaporation before plant uptake.

HOLDING & STORAGE

Harmful if inhaled or absorbed through skin. Avoid contact with skin, eyes, or clothing. Avoid breathing in spray mist. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or smoking tobacco. Remove and wash contaminated clothing before reuse. Personal Protective Equipment: Wear chemical-resistant gloves, long-sleeved shirt, long pant, and shoes with socks.

DIRECTIONS FOR USE

In all cases, follow chemical manufacturer's label or speak with your certified crop advisor.

Stick-It-Tight is a non-foaming surfactant that is compatible with most chemical formulations including dry flowables. If tank mix concerns arise, perform a jar test.

FIRST AID

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for about 15 to 20 minutes.

IF INHALED: Move person to fresh air. If person is not breathing, call 9-1-1 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after rinsing the eye.

IF INGESTED: Call the POISON CONTROL CENTER at 800-222-1222 or call a doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by Poison Control Center or doctor. DO NOT give anything by mouth to an unconscious person.

IF EXPOSED OR CONCERNED: Get medical advice/attention if you feel unwell. Immediately call POISON CONTROL.

MIXING INSTRUCTIONS:

Always check pesticide label before use. Suggested rates below:

RATE OF STICK-IT-TIGHT (per 100 gal spray mixture)

- Insecticides/Miticides/Fungicides..... ½ - 2 pints
- Herbicides..... 1 - 4 pints
- Glyphosate Formulations (Without Added Surfactants)..... 8 pints
- Defoliants..... 1 - 4 pints
- Fertilizers & Micronutrients..... ½ - 2 pints

Note: 2 Pints = 1 Quart; 4 Quarts = 1 Gallon

In difficult wetting situations such as hard water or mature waxy foliage, use the higher rate.

Aquatic use: 1 - 2 quarts of Stick-It-Tight per 100 gallons of spray solutions in aquatic weed application. Always follow herbicide label for specific directions.

This product has demonstrated excellent plant safety; however, not all species and varieties have been tested. Before treating a large area, treat a small area and observe prior to full-scale application.
